Proposition 1 – BBKA Board of Trustees

Ratification of Annex C to the BBKA Constitution, Trustee Discipline and Dispute Resolution Procedure.

Estimated costs: see below.

Supporting Notes

In the 2019 ADM Delegates approved in principle the new discipline and grievance procedure which will form part of Annex C of the CIO Constitution subject to revision which was to be presented for ratification at the 2020 ADM. The Chair of Standing Orders and Governance worked with former Magistrate Alison Hine (Shropshire North) and Padraig Floyd (Essex) to revise the policy and procedure. This led to the production of Section 12 of Annex C which sets out, in simplified form, the procedures to be followed and the levels at which they would be applied. In both cases the final appeal is heard by an external body. In the case of gross misconduct leading to the removal of a Trustee where the matter cannot be resolved by the Board of Trustees then the final Arbiter would be appointed by the President of the Chartered Institute of Arbitrators. In lesser cases where the matter cannot be resolved by the Board of Trustees then the final decision will made by the HR Professional employed by the BBKA at the time.

All Trustees will receive training in conflict resolution at the start of their Trusteeship

There will be a cost to this which could be significant in the case of serious misconduct but it will be no more expensive than an SDM. It will also be fair, transparent, far less disruptive and should never be required.

Proposition 2 – BBKA Board of Trustees

That the position of Honorary Treasurer is no longer required and that the constitution be amended to reflect this.

Estimated costs: nil

Supporting Notes

The reference to Treasurer is historical, when the BBKA's finances were both controlled and managed by volunteers. The financial policies are decided by the Trustees through the finance committee, but the actual accounting is now done through the BBKA office team, including employees with appropriate accounting knowledge, experience and qualifications. The financial statements are of course audited. The named position of Treasurer is therefore redundant.

In addition there is reference to the Treasurer of the examinations board. This post has not been filled in the recent past with the finances being dealt with by the committee and the office. Should circumstances change in the future the position could be reinstated.

Proposition 3 – BBKA Board of Trustees

That Clause 21.1 of the BBKA CIO constitution be amended to read:

AAM's will complete a declaration of their membership biannually as at the primary date of 1st April and secondary date of 1st September which form the basis of the payments that are to be made to the BBKA. The format of such updates will be determined by the Board to meet current operational needs.

Estimated costs: nil

Supporting Notes

The existing paragraph refers to the arrangements in place with the old database, rather the new arrangements under eReturn2. This amendment allows the BBKA discretion to manage the exact format of the arrangements that might change from time to time and need not be detailed in the constitution.

Proposition 4 – BBKA Board of Trustees

That Clauses 14.4 and 14.5 of the BBKA CIO constitution are replaced with the clause:

- 14.4 Vacancies will be a single vote at the ADM with candidates ranked in order of the number of votes they receive. This order will be used to fill the vacancies, with the candidates with the highest number of votes filling the vacancies for the longest terms.
- 14.5 Vacancies for the Examination Board will be dealt with as outlined in clause 14.4.

Supporting notes

The current arrangements involve multiple votes for different term lengths. This tends to be confusing for delegates and in almost all cases does not lead to a different result to that of a single vote.

Proposition 5 – West Sussex Beekeepers' Association

That the provision for proxy voting at a BBKA ADM and SDM is only activated when the physical attendance is 90% of AAMs at the start of the meeting.

Estimated costs: Nil. Administration time only.

Supporting Comments

BBKA Constitution rule 12.5 (b) states "*The quorum for a delegate meeting shall be two thirds of the number of AAMs immediately preceding the meeting*". Rule 12.6 (a) states "*Proxy voting is permitted subject to the provisions of annex (d)*". The latter was introduced at the 2019 ADM.

Proxy voting may mean there is a temptation for AAMs who may not be serious about the business to take the easy option and appoint a proxy instead of sending a delegate to a meeting. Several AAMs taking this route could mean the quorum is not met, so putting the holding of the meeting at risk, with relevant costs, disruption and inconvenience. We should be sympathetic to AAMs who are a long distance away and where delegates have unexpected illness, travel issues etc so we need to accommodate them. A relatively high physical attendance before proxy voting is activated should discourage non-attendance by disinterested AAMs.

BBKA Board of Trustees Comments: The definition of a proxy vote is that they are counted as being physically present at a meeting. Proxy votes would therefore count towards the quorum which is 2/3 of the number of Area Association Members (currently 50 as there are 76 AAMs). If AAMs wish to propose removing proxy voting this would need a change to the constitution and therefore a proposition to this effect put to a future ADM. However it could be argued that as proxy voting was only adopted in January 2019 there needs to be a three year interval before such a proposition can be considered.

Proposition 6 – Newcastle & District BKA

For the BBKA to amend the title of Chairman to Chair.

Estimated costs: Negligible

Supporting Comments

Given that the last two BBKA Chairs have been women it feels somewhat odd to still retain the official title chairman in common usage. We respectfully suggest that to make the BBKA more inclusive and to bring other documentation and publications into line with the BBKA's CIO constitution that the gender neutral term chair is adopted.

<u>BBKA Board of Trustees Comments</u>: The title Chair has already been widely adopted by the BBKA and as publications are reprinted in the future this change could be reflected.

Proposition 7 – Cumbria BKA

That new applicants for Area Association status should have a minimum of 50 paying members.

Estimated costs: This proposition would have a marginal decrease in costs to BBKA

Supporting Comments

A change to the constitution with a suggested addition in clause 10.1.1 with the inclusion of 'Area Associations that join after 1st January 2020 will be subject to a minimum annual payment equivalent to 50 times the capitation rate'.

Reasons:

- to reduce the fragmentation of the BBKA Area Associations, maintains a balanced democratic structure of BBKA
- to allow the long term success of AAs there needs to be a reasonable pool of members from which a managing executive can be selected
- any new groups which are smaller than 50 can apply to become branch members of existing AAs.

BBKA Board of Trustees Comments: BBKA is neutral on this proposition.

Proposition 8 – Yorkshire

District Associations applying for Area Association status should comply with a minimum number of full members.

Supporting Notes

The principle whereby associations should be of a reasonable size and be totally self-sufficient has been discarded and this has led (potentially) to the formation of many small associations – some with only a dozen or so members – which inevitably leads to a diverse and thinly scattered pattern throughout the UK unless it is checked. Very often it becomes evident that the reason for forming a new association is a means of resolving a local dispute and the BBKA needs to be more pro-active in encouraging members to investigate alternative ways of dealing with these issues. Regardless, it can easily lead to an inefficient and unwieldy structure which should be avoided and arguably the larger AAM's will end up subsidising the inevitably higher costs and running expenses incurred. It is our recommendation that the BBKA should impose a minimum of 100 members (based on the average membership over a three year period) before considering an application from a new association for independent status.

Estimated Costs: N/A

BBKA Board of Trustees Comments: BBKA is neutral on this proposition.

Proposition 9 - Yorkshire

In order to facilitate the views of all BBKA members, delegates should (as the default option) be able to register their votes which represent the members of that AAM rather than as an individual. Clause 12.6(b) of the CIO states: "A resolution put to the vote of a meeting shall be decided using an electronic voting system, unless the meeting decides that a Poll (poll card vote) should be taken. A registered membership vote may be demanded (before or after the declaration of an electronic or card vote) by the trustees or by one delegate present at the meeting".

This would be replaced with: "A resolution put to the vote of a meeting shall be decided by a registered membership vote using an electronic voting system

Estimated Cost: Nil

Supporting Notes

AAM's operate a one member, one vote system and all members may vote at local meetings/AGM's and have every right to assume that their views will be represented at a higher level, where appropriate. By continuing the system of allowing delegates to vote as an individual denies members this right and places power within the hands of the few who engage with the formal process. Before the introduction of an electronic voting system we acknowledge that it was difficult to count a large number of disparate voting numbers but new technology enables this to be done with ease and therefore this should now be the default way and reflects a fairer way of recording the wishes of the membership as a whole.

BBKA Board of Trustees Comments: The BBKA feel that supporting this proposition would be unfair in that it would have the effect of disenfranchising the smaller Area Association Members. It would also mean changing the BBKA constitution.

Proposition 10 – Yorkshire BKA

The reintroduction of a YEAR BOOK.

Estimated costs: for software modifications: £ 150 (figure supplied by BBKA office).

Supporting Notes

The Year Book ceased to be published post 2016 due, supposedly, for financial reasons but our investigations suggest there may have been others. Many AAM officers previously regarded the YEAR BOOK as a valuable and informative source of information...essentially acting as 'the bible'.....they now have to totally rely on the Website for seeking information. Several reasons for ceasing publication of the book have been suggested: (a) The year book becomes very quickly out of date because of changes in officers (b) New legislation regarding privacy rules (GDPR) means that the BBKA would need to ask every officer for their permission to include their details....surely this applies if the information is published on the website? (c) Every Chair, Secretary, Exam and Membership Secretaries would be compelled to give written permission to include their details and there is concern that, if it was made public and for sale, many officers would decline to have their details included.

The BBKA Year Book is greatly missed by AAM officers as it was such a valuable source of information. The BBKA should investigate creating, within eReturn2, an electronic list of AAM officers which is only available to other AAM officers.

BBKA Board of Trustees Comments: The BBKA is already working with the software developers of eReturn2 membership database to create a directory of all Area Association Officers within eR2 that will be available to other AAM Officers.

Proposition 11 – Yorkshire BKA

The BBKA should refrain from allowing members to register as Full members for more than ONE Association

Estimated Cost: Nil

Supporting Notes

By allowing members to register for more than one association this effectively dilutes their loyalty and commitment to their local Association and this potentially could lead to the creation of discord and a

conflict of interests. This also means that any such member would receive multiple copies of the monthly magazine/Newsletter which is not only inefficient but it is also artificially and unnecessarily swelling BBKA funds.

No checks appear to be carried out and it is our suggestion that, If a member wishes to register with the BBKA as a full member with another AAM (when they are already a full member with another) then a mechanism needs to be introduced (i.e. new class of member) which will enable them to do so without the need for them to register for a second (or third) time as a full member with another AAM. <u>Note:</u> It is estimated that an extra 2 days per week is needed by the BBKA administrative team to answer queries and process applications, bearing in mind that there is no fixed renewal date and so new members apply to join or renew their membership all year round. A lot of time is also spent reminding members to pay and lapsing them.

<u>BBKA Board of Trustees Comments:</u> The BBKA does not, nor would wish to, have any control over whether an individual joins more than one beekeeping group.

Proposition 12 – Surrey BKA

That the BBKA will seek quotes to take out Public and Personal Liability insurance cover for up to 15 designated members of each local branch or division of BBKA Area Associations' Members to cover yellow legged (Asian) hornet nest searching, but not the destruction of nests.

Cover to be implemented by 31st March 2020 to cover the start of the 2020 active season unless BBKA trustees identify a compelling reason not to do so and explain their reasons in BBKA News for all members to see.

Designated branch or division members must have received online 'Basic safety training' (or paper equivalent) that satisfies the insurers, on how to carry out yellow legged (Asian) hornet nest searching.

Supporting Notes Why Required

People searching for an Asian Hornet nest could accidently disturb it and cause an attack on a member of the public and be sued. If Asian Hornets start to establish themselves beekeepers need volunteers ready to help as the NBU may be overwhelmed.

BDI insurance does not cover individuals searching for Asian Hornet nests and existing household insurance is unlikely to give cover; without insurance Beekeepers may refuse to help.

How it works

- 1. Each AHAT would have up to 15 volunteers to be named Asian Hornet searchers.
- 2. Each person would be required to watch the online PowerPoint (if not online access hard copy could be sent out to the person by the AHAT) and send a signed form back to the AHAT AHAT to file. Names are submitted and filed by BBKA.
- 3. Insurance company are thus ensured that the 'searchers' have undergone basic training e.g. do not hit a nest with a stick or prod it.
- 4. In the event of a sighting of a hornet the AHAT co-ordinator has 15 trained, insured people to support the NBU in searching for a nest.

Supporting Information for Costing

Based on a horse and rider cost £10 a year <u>https://harryhall.com/horse-public-liability-insurance</u> Searching for an Asian Hornet Nest, with people who have completed basic training should be a lower risk.

BBKA Board of Trustees Comments: The BBKA are currently awaiting a decision from insurers. However, if agreed, it will not cover members for trespass or for catching and releasing Asian hornets. Asian hornets remain an invasive species and it is against the law to release them.

Proposition 13 – Buckinghamshire BKA

That the BBKA should raise pollinator awareness amongst planning and landscaping professionals, in training.

Estimated costs: £1,500 for the attendance at meetings to hone proposals and potentially £1500 for the development of materials (similar to the BBKA Course-in-a-Case, as a model). Subsequent beekeeper attendance at specific professional courses or events would be the subject of negotiation with the relevant body.

Supporting Notes

There are over 30 universities offering graduate and post-graduate planning and landscaping courses in the UK. The graduates of these courses are the people who will determine planning decisions, or at least advise on their determination, as well as influence environmental and landscaping elements of future land use and development.

It is therefore important that such professional training embraces an awareness of opportunities to enhance pollinator environments. To this end, the BBKA shall establish contact with such institutions and appropriate course accreditation bodies to establish how pollinator course material or expertise can be most appropriately provided or secured, and, where appropriate, provide or develop such material tailored to the profession, including, where appropriate, speakers to such bodies.

It is envisaged that time and money spent on raising the pollinator awareness of planning and landscaping professionals in training will, over the course of their working life, yield significant dividends for pollinators in general, honey bees in particular, and therefore beekeepers for decades to come.

BBKA Board of Trustees Comments: In principle we are in favour of this proposition. However, currently the BBKA do not have the personnel to develop such material. We would be interested in a more detailed, fully costed business proposal.

Proposition 14 - Essex BKA

That BBKA mandate its CONBA representatives to actively pursue the United Kingdom becoming a member of Apimondia.

Estimated costs: the annual membership fee for the UK is 1,125 euro and there is an initial joining fee of 200 euro. Annual cost per BBKA member about 3.5p.

Supporting Notes

Apimondia is the International Federation of Beekeepers Association. It has 118 members, 33 are European countries, UK is not a member. Its purpose is the facilitation of the exchange of information about apiculture. Its principle event is a bi-annual international conference. The UK is required to join as a single entity which will also require agreement of the BBKA, Scottish, Welsh and Ulster BKAs.

CONBA is the single body which represents the interests of the BBKA, Scottish, Welsh and Ulster BKAs.

The benefits would be proper representation and recognition of the UK in the world of beekeeping and £50 discount on Apimondia attendance fee.

Three letters of support from IBRA (International Bee Research Association), Bees Abroad and Bees for Development have been received in support of this proposition.

BBKA Board of Trustees Comments: Trustees Anne Rowberry and Pam Hunter represent the BBKA at CONBA meetings. BBKA is happy to pursue these discussions however it must be stressed that the Scottish, Welsh and Ulster BKAs will need to agree.

Proposition 15 – West Sussex Beekeepers' Association

This meeting instructs BBKA to apply for and if accepted to become a full member of Apimondia.

Estimated costs: 200 euro entry fee plus 1,125 euros per year.

Supporting Notes

Apimondia is the International Federation of Beekeepers Associations. It was inaugurated in 1893, so has a long history of benefitting all beekeepers worldwide. It is desirable for British Beekeepers to be part of and have a voice in the international beekeeping community.

BBKA Board of Trustees Comments: BBKA is unable to apply for membership direct to Apimondia. The UK is required to join as a single entity which will also require agreement of the BBKA, Scottish, Welsh and Ulster BKAs.

The following propositions are unable to be considered by the ADM as they concern the Exam Board. The propositions have been passed to the Exam Board for their attention.

a) Yorkshire BKA

To consider re-naming the BASIC assessment.

Estimated Cost: Nil

Supporting Notes

It is our contention that calling this a BASIC qualification – a negative phrase – doesn't provide a strong enough incentive for new (and old) beekeepers to consider taking it. We believe it would give it greater credibility should it be regarded and acknowledged (by it's wording) as a vital stepping-stone to a higher status. Suggestions: APIARIST (Stage 1); Beekeeping PROFICIENCY Certificate or Beekeeping Certificate (FOUNDATION LEVEL).

b) <u>Cleveland</u>

That the BBKA examination programme should have some independent verification/standardisation and be aligned to national standards.

Estimated costs: This should be achievable within the meetings of the Exam Board and by email, therefore be at no cost to the BBKA. The outcome of the review may require expenditure, but this cannot be estimated at this time.

Supporting Notes

Firstly, the proposer recognises that this cannot be undertaken quickly and would anticipate this taking at least two years to implement.

The BBKA website includes the statement 'our written and practical examinations support our desire to set high standards to educate our beekeepers'. What is that 'high' standard? What does Master Beekeeper really mean in terms of knowledge, skills and attitudes?

It is unfair that those undertaking the examinations and assessments do not understand the context of the BBKA education system; many of whom have not undertaken formal assessments since leaving full time education. Is it Entry Level of the RQF (Regulated Qualification Framework) or Level 2 (e.g. GCSE grade 4 to 9) or perhaps Level 3 (A level)?

Setting the BBKA qualifications against a national standard would increase the standing of the qualifications and genuinely make them of a high standard as the BBKA desires.

Taking no action would expose the system to adverse comment, perhaps even ridicule as 'being just for fun'- not the expectation or experience of candidates.

c) <u>Cleveland</u>

That the BBKA reviews the Examinations System to ensure it meets the principles of the Equality Act

Estimated costs: This should be achievable within the meetings of the Exam Board and by email, therefore be at no cost to the BBKA. The outcome of the review may require expenditure, but this cannot be estimated at this time.

Supporting Notes

As an inclusive organisation and Charity, the BBKA needs to ensure that the Exam System does not discriminate and is protected, as much as possible, from unconscious bias.

Two examples from 2019 suggest that the BBKA needs to review its processes to meet the highest standards. The first is the requirement to use a Stereo Microscopy for the Microscopy Assessment or Advanced Husbandry when an applicant has visual problems where modern digital dissecting scopes that allow viewing with an LCD screen could be used.

The second example relates to a failure of the BBKA to apply the same process to a candidate for a practical assessment who had mental health related problems as it would to one with physical needs. In the mental health related case the information provided by the candidate was only used in moderation, whereas in a physical difficulty the assessors would necessarily know in anticipation of the assessment. This is a breach of the concept of "Parity of Esteem" currently promoted by health professionals and the NHS.
